#### **Notice To Seller:**

Seller's Information:

It is presumed that all sales are subject to Sales Tax until the contrary is established. The burden of proof is on the seller that the sale of tangible personal property is not a retail sale. However, if the seller receives a resale certificate signed by the purchaser stating that the property is purchased for resale, the liability for the Sales Tax shifts from the seller to the purchaser.

This certificate is intended for use by licensed retail merchants purchasing tangible personal property for resale, lease or rental purposes. To be valid, the following conditions must be met:

- 1. The resale certificate presented to the seller by the purchaser contains all the information required by the SCDOR and has been fully and properly completed.
- 2. The seller did not fraudulently fail to collect or remit the tax, or both.
- 3. The seller did not solicit a purchaser to participate in an unlawful claim that a sale was for resale.

The seller must maintain a copy of this certificate to substantiate the exemption in the event of an audit. This certificate is not valid if it does not meet the above requirements, and the seller remains liable for the tax.

- You now have a Sales & Use Tax account and are required to file returns and pay Sales Tax from your retail sales beginning with the effective date of this license.
- The Retail License is only valid for the location address displayed on the license.
- If you sell your business, the new owner must apply for a new license in their name.
- The SCDOR now issues licenses on standard white paper. Previously issued licenses are still valid and don't need to be updated unless your information changes.

### What you need to do:

- You must display your Retail License in a visible location.
  - You must also display the attached sign regarding the Sales Tax reduction for individuals 85 and older and honor the reduction if requested.
- You must file a return even if you have zero sales for the filing period.
- We recommend you file all returns and make all payments electronically using MyDORWAY, our free online tax portal, at MyDORWAY.dor.sc.gov.
- If you've never created a MyDORWAY account, visit dor.sc.gov/MyDORWAY-signup. You'll need the following information to get started:
  - Your FEIN, SSN, or South Carolina ID (SID)
  - Your file number Displayed at the top of this letter
  - Letter ID Displayed at the top of this letter
- If you already use MyDORWAY to manage your other SC tax accounts, you can add account access to your MyDORWAY logon. Log in to MyDORWAY.dor.sc.gov. Select the More tab, then click Request Account Access.

### **General Information:**

- Any request to update your Sales & Use Tax account should be completed on MyDORWAY. Log in to MyDORWAY.dor.sc.gov. Select the More tab, where you will find the following options:
  - Manage Names & Addresses
  - Close a Tax Account
  - Send the SCDOR a Message
- You can print your licenses from MyDORWAY by selecting the More tab, then View Letters, then searching for the Retail License.
